# Manager's Message

The 70th Annual Meeting of Members for Hill County Electric Cooperative (HCE) was held on May 9th in the Student Union Building on the MSU-Northern campus. It was a productive and informative time for all. Attendance was good this year with 76 voting members being present. We are indeed thankful for those that came out to the meeting on such a beautiful morning.

Board President, Stu Smith, brought the meeting to order on time. Up for re-election this year were Gerald Rutledge from District 4, generally comprised of the southern service area and Clarence (Fritz) Keller serving the "at-large" service district that includes all the cooperative's districts. Both were nominated by HCE's nominating committee to represent their respective districts. No nominations were received from the floor and both candidates were re-elected to the Board with a vote of acclamation by the members present. The Board officers will remain the same with Stuart Smith as President, Clarence (Fritz) Keller as Vice President and Lon Waid as Secretary/Treasurer. Gerald Rutledge and Merle Belcourt are the other two current members of the HCE Board of Trustees.

Gail Rainey, Assistant General Manager, provided a detailed update on the financial condition of the Cooperative noting that HCE is in good financial condition. Gail also reported on capital projects that have been completed and the recent capital credit refunds that were made to HCE members.

Four "Luck of the Draw" scholarships were awarded to HCE member dependents who attended the meeting with their parent or guardian. Winners included: Meagan Passon and Alissa Borlaug, \$500 each; Mackenzie Hansen, \$300; Michael Compton, \$200 and Josh Viall received a \$100 attendance scholarship.

HCE members, Kelly and Kristi Rutledge, discussed the Montana Electric Cooperatives' Association (MECA) Today's Member program they attended on behalf of HCE last October. The Rutledges reported the program was extremely informational and encouraged other members to apply. They also thanked the HCE Board for selecting them.

Good news was provided again this year by Doug Hardy, General Manager of Central Montana Electric Power Cooperative (Central), HCE's contract power supplier. Doug noted that wholesale power supply costs in 2014 remained stable so no wholesale rate increases were required in 2015. This allowed HCE to hold its retail rates steady again this year. HCE members who have joined our grassroots program were thanked by Gary Wiens, MECA's Assistant General Manager. When legislation was proposed that negatively affected our electric cooperatives, the grassroots members were alerted and instructed on what to do to help. Those that responded truly made a difference for our cooperative this past legislative session.

Important issues discussed at the meeting were as follows:

The Environmental Protection Agency (EPA) is pushing forward with new, more restrictive environmental regulations for primarily coal fired electricity generation. We are not opposed to new environmental regulation as long as it is combined with a common sense approach. As noted last year, the new regulations being proposed will cost billions of additional dollars, raise wholesale power rates by 75 to 80% based on the EPA's own estimates and provide minimal environmental benefits. That is NOT reasonable, does not show good common sense and therefore is NOT good environmental policy.


Secondly, the "waters of the United States". The Army Corps of Engineers and the EPA want to control all of the waters throughout the United States including small reservoirs and streams that only run a short time each year.

This would cause delays in our ability to repair poles and lines.

Last, was "coal ash". Each year coal ash must be approved to be listed as a non-hazardous substance. Cooperatives would like to have coal ash permanently listed as a non-hazardous substance.

As I did at the annual meeting, I would again like to thank the Board of Trustees for representing our membership so well. I also announced my retirement from the co-op effective the end of this year. I would like to thank everyone for their assistance these past years. I also encourage you to visit our website, www.HillCountyElectric.coop, and take a look at our in-house produced video, "Life of a Lineman". It is a fitting tribute to our dedicated linemen.


The time and money spent in providing young people with a chance to attend summer camp can well be considered an investment in our future, with the hope and assurance that these people will be better citizens.

# Have You Checked Into A **Ground Source Heat Pump** Lately?

What is a Ground Source Heat Pump (GSHP)? GSHPs use the earth's stable temperature to heat and cool a home or business. A liquid cycles through a "loop field" and simply moves the heat from one location to another as shown in the diagram to the right. The whole system is highly efficient, which means lower cost to you, plus it is environmentally friendly.

Hill County Electric (HCE) is excited to offer a new promotion for HCE members interested in installing a GSHP system. HCE will pay for the first year of electric energy costs and special metering installation.
